WHEREAS, at the October 6, 1975 meeting of the Public Facilities and Recreation Committee, a resolution was adopted to recommend that the City Council approve the concept of providing a \$50,000 fund to be matched by private contributions for the purpose of erecting an appropriate Bicentennial Memorial structure; and

WHEREAS, the committee directed that the source of the \$50,000 be recommended by the City Manager and further directed that the monies were not to be taken from the General Fund; and

WHEREAS, a resolution was also adopted to recommend to the Council that a task force be appointed by the Mayor and Council to determine the nature and location of the memorial; and

WHEREAS, the City Manager has recommended that the source of funds be the Capital Outlay Fund Reserve 245; NOW, THEREFORE,

BE IT RESOLVED, that the expenditure of not to exceed \$50,000 from the Capital Outlay Fund Reserve 245, which sum shall be matched by private contributions and expended for the purpose of financing the acquisition and/or construction of an appropriate Bicentennial Memorial, is hereby authorized.

BE IT FURTHER RESOLVED, that the Mayor and the City Council shall appoint a task force for the purpose of deciding what the memorial should be and where it should be located.
