

RESOLUTION NO. 214606

WHEREAS, Toltecas en Aztlan, Inc. (herein called Toltecas), had provided services through contractual agreement with City to coordinate efforts of Chicano artists and promote Chicano cultural heritage; and

WHEREAS, Toltecas no longer possesses nonprofit corporation status and therefore no longer meets the criteria established by City for such funding; and

WHEREAS, it is deemed desirable to continue said endeavors to assure a continuity of such cultural promotional effort; and

WHEREAS, Centro Cultural de la Raza, Inc. (herein called Centro) has been incorporated as a nonprofit corporation for the same purpose and involving the same personnel as existed previously in Toltecas, and meets all funding criteria established by City; and

WHEREAS, Centro has offered to provide those services previously conducted by Toltecas so that the proposed cultural efforts may continue uninterrupted; and

WHEREAS, Centro has submitted a proposed budget and program of activity which appears to duplicate that previously approved for Toltecas; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an



agreement with CENTRO CULTURAL DE LA RAZA, INC., for the purpose of coordinating the efforts of Chicano artists through enhancement of Chicano artistic skills, development of a Chicano Cultural Center, and promotion of Chicano cultural heritage and contemporary creative achievements, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 753238 .

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$23,800 from the 223 Fund Contingency Reserve (52.29) to an appropriate account (52.54) to be established by the Auditor, said funds to be used solely and exclusively for funding Centro Cultural de la Raza, Inc. pursuant to the above cited agreement.
