WHEREAS, San Diego State University's climb to national prominence in football competition began in 1961; and

WHEREAS, in the following 14 years, Aztec football teams have gained a national reputation for excellence and for producing many football players who go on to distinguish themselves in professional football careers; and

WHEREAS, the San Diego State Aztecs in 1975 have one of its most challenging and difficult schedules in its history; and

WHEREAS, this year's Aztec team has eight straight victories without a loss, and is one of only six major college football teams enjoying an undefeated season; and

WHEREAS, the Aztecs this week attained its highest ranking in national football polls, being rated 12th in the nation by United Press International and 13th by the Associationed Press; and

WHEREAS, for the first time in Aztec history, San Diego Stadium is sold out for this week's important game with the University of Arizona, ranked 15th in both polls; and

WHEREAS, Aztec coaches and fans are suggesting that Saturday's game may be the most important in the Aztec's long climb to national prominence for football excellence; NOW, THEREFORE,
