WHEREAS, a certain sewer easement was granted in Block 5 of Tia Juana City, by deed recorded October 13, 1971 as Instrument No. 236023 of Official Records of said County; and

WHEREAS, the State of California, Department of Transportation, the owner of said property, has requested that the City vacate its interest in said easement to correct an erroneously described easement location; and

WHEREAS, said sewer easement has never been used for the purpose for which it was granted since the date of recording said deed to the present time and more than one (1) year has elapsed; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and

WHEREAS, said easement as hereinafter described is unnecessary for present or prospective public use by the City, and the City Manager recommends that the City vacate said sewer easement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That, pursuant to Section 50443 of the Government Code of the State of California, the sewer easement more particularly described in the legal description attached hereto as Exhibit A and by this reference incorporated herein, is hereby vacated.



That from and after the date of this order of vacation, title to the land previously subject to said easement shall revert to the owner of the land free from the rights of the public.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the Recorder of said County of San Diego.

## LEGAL DESCRIPTION
