

RESOLUTION NO. 214634

WHEREAS, The City of San Diego is the owner of certain lands in a portion of Pueblo Lot 259 of the Pueblo Lands of San Diego, being those portions of Lapwai Street and Knoxville Street, now vacated and closed to public use; and

WHEREAS, the SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, has requested the conveyance of an easement for the purpose of underground gas facilities across said property to provide continued right-of-way for gas facilities previously located within a franchise area; and

WHEREAS, the purposes for which the easement is required are public purposes; and

WHEREAS, Section 22.0907 of the San Diego Municipal Code authorizes the conveyance of city property to public agencies for public purposes without complying with the provisions relating to the advertising for bids and auction sales contained in the Municipal Code; and

WHEREAS, the City Manager, pursuant to Section 22.0907 of the San Diego Municipal Code, has recommended that said easement be conveyed to the San Diego Gas & Electric Company, a corporation,
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,



That, in consideration of the benefits to accrue to the people of said City, the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a deed conveying to the SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, an easement for the purpose of underground gas facilities across said portion of Pueblo Lot 259, as more particularly described said deed, the form of which is on file in the office of the City Clerk as Document No. 753316.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
