That the acceptance by the City Manager of that deed of WARREN M. NICHOLS, Executor, and WARREN MASON NICHOLS, Trustee, executed in favor of The City of San Diego, bearing date of August 14, 1975, conveying to said City the permanent easements for street and drainage purposes affecting a portion of the Northwest Quarter of the Northeast Quarter of Section 34, Township 14 South, Range 2 West, S.B.M., as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named SEMILLON BOULEVARD.

BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby authorized and empowered to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the Office of the County Recorder of San Diego County.
