


RESOLUTION No. 214649Adopted on NOV 12 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, executed in favor of The City of San Diego, bearing date of August 14, 1975, conveying to said City an easement for slope purposes over and across a portion of Pueblo Lot 1176 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, a copy of which was filed in the office of the County Recorder of said County, November 14, 1921 and is known as Miscellaneous Map No. 36, as more particularly described in said deed, be and the same is hereby approved.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director of said City for further handling.
