


RESOLUTION No. 214650Adopted on NOV 12 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of ROI, LTD., a limited partnership, executed in favor of The City of San Diego, bearing date of August 21, 1975, conveying to said City for street and slope purposes a portion of Lots 1, 3 and 4 in Block 12 of Silver Terrace being a subdivision of a portion of Pueblo Lot 1177, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named LINDA VISTA ROAD.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director of said City for further handling.
