


RESOLUTION No. 214651Adopted on NOV 12 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of VALLEY VIEW INVESTORS, a General Partnership, executed in favor of The City of San Diego, bearing date of September 25, 1975, conveying to said City the permanent easement and right-of-way for a public street and incidents thereto across a portion of Lots 2 through 11, inclusive of Lot 2 of Bay View Addition, according to Map thereof No. 271 filed in the Office of the County Recorder of San Diego County, July 23, 1887, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named GAINES STREET; and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street and the same is hereby named DONAHUE STREET; and the land therein conveyed as Parcel 3 is hereby dedicated as and for a public street and the same is hereby named EUREKA STREET.

That the City Clerk of said City is hereby authorized and empowered to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the Office of the County Recorder of San Diego County.
