BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$3,958.00 from Gas Tax Fund 220 for acquisition of the above described property is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
