

RESOLUTION NO. 214663

WHEREAS, the improvement agreement for Scripps Ranch Unit No. 7 subdivision required the developer to install a 12-inch sewer main in the future alignment of Pomerado Road; and

WHEREAS, since the desired alignment and grade for this sewer is such that it cannot be installed until the new Pomerado Road is under construction; and

WHEREAS, since the sewer is not needed at this time, the Utilities Department recommends that a cash contribution of \$13,038 from the subdivider be accepted in lieu of present construction of the sewer; and

WHEREAS, the developer has placed on deposit a check for such amount to be used by City for the sewer; and

WHEREAS, when the new Pomerado Road is constructed, this money will be used to finance the cost of construction of said sewer; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager is hereby authorized to accept \$13,038 placed with City by the Scripps Ranch Unit No. 7 developer in lieu of construction of a 12-inch sewer main in Pomerado Road; said funds to be used to finance said sewer when construction is possible and feasible.
