That the City Manager of the City of San Diego is authorized to execute a modification to the contract with International Business Machines authorized by Resolution No. 211392 for the LEASE OF A DATA PROCESSING SYSTEM by changing the amount for the period beginning July 1, 1975 through December 31, 1975 from \$38,877.00 per month plus tax to \$40,315.00 per month plus tax, and to increase the amount beginning January 1, 1976 from \$52,003.00 per month plus tax to \$54,115.00 per month plus tax.
