BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with SHOLDERS & SANFORD, INC., a California corporation, for professional engineering services for design of the CLAIREMONT BIKEWAY, between Arvinels Avenue and Balboa Avenue, and the FRIARS ROAD BIKEWAY, between Ulric Street and Fashion Valley Road, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 753377.

BE IT FURTHER RESOLVED, that the expenditure of \$6,800 and \$6,200 is hereby authorized out of Gas Tax Fund 220 and Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above referenced services.
