

RESOLUTION No. 214701Adopted on NOV 19 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

BE IT FURTHER RESOLVED, that the expenditure of \$20,000 is hereby authorized out of Storm Drain Bond Fund 727 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above referenced services.
