
Adopted on NOV 26 1975

That the acceptance by the City Manager of that deed of THE ROMAN CATHOLIC BISHOP OF SAN DIEGO, a corporation sole, executed in favor of The City of San Diego, bearing date of May 29, 1975, conveying to said City the permanent easement and right of way for an earth excavation, or embankment, slope or slopes and incidents thereto, over and across a portion of Lots 9 and 10 ~~in~~ Block 20 of Silver Terrace, according to Map thereof No. 434, filed in the Office of the County Recorder of San Diego County December 24, 1887, as more particularly described in said deed, be and the same is hereby approved.

That the expenditure of \$601 from Gas Tax Fund 244 is hereby authorized solely and exclusively for acquisition of the above described property.
