

RESOLUTION No. 214744


Adopted on NOV 26 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of JOHN ROBERT DEAN and DONNA GAILE DEAN, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of September 17, 1975, conveying to said City the permanent easement and right-of-way for a public street and incidents thereto, over, under, upon, along and across a portion of Section 30, Township 14 South, Range 3 West, S.B.M., as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named ARROYO SORRENTO ROAD.

That the City Clerk is hereby authorized and empowered to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder of San Diego County.
