BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the UNIVERSITY OF SAN DIEGO, a corporation, executed in favor of The City of San Diego, bearing date of September 19, 1975, conveying to said City the permanent easement and right-of-way for a public street and incidents thereto and an earth excavation or embankment, slope or slopes and incidents thereto, over, under, upon, along and across portions of Lots 4 and 5 in Block "A" of Silver Terrace Addition, according to Map thereof No. 695 on file in the Office of the San Diego County Recorder, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named LINDA VISTA ROAD.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
