

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the UNIVERSITY OF SAN DIEGO, a corporation, executed in favor of The City of San Diego, bearing date of September 19, 1975, conveying to said City the permanent easement and right-of-way for a public street and incidents thereto, over, under, upon, along and across a portion of Pueblo Lot 1177 of the Pueblo Lands of San Diego, according to Map thereof by James Pascoe in 1870, a copy of which was filed November 14, 1921 known as Miscellaneous Map No. 36, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named LINDA VISTA ROAD.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.


