

RESOLUTION No. 214755Adopted on **NOV 26 1975**


BE IT RESOLVED, by the Council of The City of San Diego as follows:

BE IT FURTHER RESOLVED, that the expenditure of \$10,000 is hereby authorized out of Local Transportation Fund 2720 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above referenced services.
