WHEREAS, the Personnel Department provides preemployment physical examinations to applicants for City employment; and

WHEREAS, such preemployment physical examinations are conducted pursuant to the requirements of and standards established by the Civil Service Commission in accordance with Civil Service Rules and regulations; and

WHEREAS, the County Health Department provides such physical examination service within the scope and range of its capability; and

WHEREAS, it is anticipated that the City will require approximately 1,000 physical examinations in the forthcoming year; and

WHEREAS, such requirement is beyond the capability of the County Health Department; and

WHEREAS, it is deemed desirable to contract with an additional medical facility to provide additional medical examining capability on an "as required" basis whenever the requirements of City cannot be accommodated by the County Health Department; and

WHEREAS, the Personnel Department solicited bids for such services on a requirement contract basis pursuant to the provisions of Council Policy No. 300-7; and

WHEREAS, seven bids were received in response to said solicitation; and
