

RESOLUTION NO. 214760 NOV 26 1975

WHEREAS, the Council of The City of San Diego, by Resolution No. 211217 dated August 1, 1974, authorized the expenditure of \$99,000 from Community Buildings and Improvements Bond Fund 726 of The City of San Diego for the sole and exclusive purpose of improving the capability and increasing the capacity of the Fire Communications Center operations; and

WHEREAS, City forces were originally authorized in conjunction with the Fire Communications Center improvement at a cost of \$8,000; and

WHEREAS, because of unanticipated difficulties encountered and additional man-hours needed by City forces; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the expenditure of \$10,700 from the Community Buildings and Improvements Bond Fund 726 of The City of San Diego is hereby authorized solely and exclusively for the purpose of completing the Fire Communications Center equipment upgrading project.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to do by City forces miscellaneous improvements in conjunction with the above referenced project, pursuant to the recommendation of the City Manager and the submission of his estimates indicating
