

RESOLUTION No. 214767Adopted on NOV 26 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

COLLINS, executed in favor of The City of San Diego, bearing date of September 16, 1975, conveying to said City a portion of Section 26, Township 18 South, Range 2 West, San Bernardino Base and Meridian, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named BEYER BOULEVARD.

That the expenditure of not to exceed \$595.00 from Gas Tax Fund 220 is hereby authorized solely and exclusively for acquisition of the above described property.

That the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
