

RESOLUTION OF INTENTION NO. 214772

NOV 26 1975

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE TIERRASANTA BOULEVARD (FORMERLY BALBOA AVENUE) IN LOT 23, ROSEDALE TRACT, MAP NO. 825; AND CLAIREMONT MESA BOULEVARD (FORMERLY MOUND AVENUE) IN LOTS 3 AND 5, BLOCK 19, RESUBDIVISION OF LOTS 14, 16, 18, 19, AND 20 IN ROSEDALE TRACT, MAP NO. 857 AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, By the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of a portion of the street hereinafter mentioned; and in connection therewith require the reservation of a certain easement for drainage purposes in the area covered by such street.

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of Tierrasanta Boulevard (formerly Balboa Avenue) in Lot 23, Rosedale Tract, Map No. 825; and Clairemont Mesa Boulevard (formerly Mound Avenue) in Lots 3 and 5, Block 19, Resubdivision of Lots 14, 16, 18, 19, and 20 in Rosedale Tract, Map No. 857 as more particularly shown on Map No. 13569-1 and 2-B, on file in the office of the City Clerk as Document No. 753459.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 8:30 A.M., JAN 15 1976 in the Council Chamber on the twelfth floor of the City Administration Building, The Charles C. Dail Concourse, 202 C Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.


