

RESOLUTION No. 214777Adopted on NOV 26 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of THE ROMAN CATHOLIC BISHOP OF SAN DIEGO, a corporation Sole as Trustee for St. Mary Magdalena Church, executed in favor of The City of San Diego, bearing date of September 19, 1975, conveying to said City a portion of Lots 134 and 135 of Morena, according to Map thereof No. 809 filed in the Office of the County Recorder of San Diego County, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby designated "WESTERN HILLS NEIGHBORHOOD PARK."

That the expenditure of not to exceed \$4,000 from Capital Outlay Fund 245 for incidental expenses related to the acquisition of the above property is hereby authorized and approved.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
