

RESOLUTION NO. 214779 NOV 26 1975

WHEREAS, The City of San Diego is the owner of a portion of Section 73 of Rancho de la Nacion, according to Map thereof No. 166 on file in the Office of the Recorder of San Diego County; and

WHEREAS, Glen Abbey Memorial Park, a California corporation, the owner of the adjoining land, has requested that the City convey to them all of the City's interest in and to a portion of said Section 73 of Rancho de la Nacion; and

WHEREAS, said land was acquired for utility purposes and has been determined surplus by the Utilities Director of said City as long as the City retains an easement for water pipeline purposes; and

WHEREAS, the deed conveying said property will reserve an easement for pipeline purposes; and

WHEREAS, the City desires to negotiate the sale of said land to Glen Abbey Memorial Park, a California corporation, under the provisions of Section 22.0902 (e) of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such an interest in real property as this may reasonably be accomplished only by negotiation; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and

WHEREAS, it has been determined by a staff appraiser of said

city that the value of the property is the sum of Four Thousand, Three Hundred Dollars (\$4,300); and

WHEREAS, no real estate broker's commission shall be paid and all costs relating to the sale will be borne by the applicant; and

WHEREAS, the sale of the aforementioned property is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That that certain real property described in that form of grant deed on file in the office of the City Clerk as Document No. 753458, be, and the same is hereby authorized to be sold by negotiation for the sum of Four Thousand, Three Hundred Dollars (\$4,300) to GLEN ABBEY MEMORIAL PARK, a California corporation.

2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, the form of which is on file in the office of the City Clerk as Document No. 753458, granting to GLEN ABBEY MEMORIAL PARK, a California corporation, a portion of Section 73, Rancho de la Nacion, according to Map thereof No. 166 on file in the Office of the Recorder of San Diego County, but reserving an easement to the City for pipeline purposes, as more particularly described in said form of grant deed.

3. That no broker's commission shall be paid by City on the herein described sale and all costs relating to the sale will be borne by the grantee.

4. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
