


RESOLUTION No. 214781Adopted on NOV 26 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Fifth Amendment to Lease Agreement with MISSION BAY MARINA, a limited partnership, amending that certain lease agreement on file in the office of the City Clerk as Document No. 603363 by increasing the minimum rent to \$20,000 per year, providing an increase in boat slip percentage to 20 percent of gross, updating several clauses and adding the Affirmative Action requirement, according to the terms and conditions set forth in the form of fifth amendment to lease agreement on file in the office of the City Clerk as Document No. 753518.
