

RESOLUTION NO. 214786Adopted on DEC 10 1975

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

Leeland E. Scholey	PARK & RECREATION Park Division	\$625	Utility Supervisor Scholey suggested making special ramps for tractor-mowers so they can be carried to parks on a flat bed truck instead of being towed by pick-ups. This has been done on three trucks, and has eliminated the need for 6000 miles per year of pick-up mileage. This saves a net of \$6,240 per year.
Herbert E. Michaels, Jr.	GENERAL SERVICES Buildings Division	\$225	Mr. Michaels, a Refrigeration Mechanic, proposed interconnecting two cooling units in the Library so that the entire load would be handled by one. The other would then be used only as a standby when the main unit requires maintenance. This saves \$1970 per year in electrical energy and \$339 in maintenance, a total of \$2,254 net.
