Allen	EMPLOYEE SERVICES	\$85	Mr. Allen, a Senior Clerk, observed that a long-standing practice of having employees on leave without pay make out checks to the City for their insurance premiums required a lot of record keeping in Employee Services and some in the Auditor's Office. Checks are now made out directly to the insurance company. This saves \$845 per year.
Nettie Pargo Irene Frimmer	LIBRARY	\$70	The suggesters, an Intermediate Typist and a Sub. Librarian, felt that the identifying magazine cards were not needed for over 25,000 paperbacks donated to the Library each year. The simplified system they have suggested saves \$713 per year in clerical time and forms.
David L. Pearston	POLICE DEPARTMENT	\$55	Officer Pearston suggested combining the Traffic Injury Report and Collision Report and modifying them. This saves time for making the reports and improves handling and filing. It is estimated this will save \$553 per year.
Kenneth R. Wood	FIRE -DEPARTMENT	\$10	Fire Fighter Wood suggested painting connections for three types of electrical apparatus with white markings. This makes the connections easier to see in dark conditions, and is expected to prevent damage to the connections from making them improperly. Savings cannot be estimated, but it is felt an award is warranted.
