BE IT RESOLVED, by the Council of The City of San Diego as follows:

R76-1119

That the bids of 1. Inland Nut and Bolt Company, 2. Gould Hardware, 3. Triangle Steel and Supply Co., 4. W.K. Montgomery Co. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of HARDWARE AND FASTENERS as may be required for a period of one (1) year beginning December 1, 1975 through November 30, 1976, per prices and escalation on file in the Purchasing Department, as follows:

1. Inland Nut and Bolt Company, for Section I, terms 1% 10 days plus sales tax.
2. Gould Hardware, for Section II, terms 2% 10th proximate plus sales tax, with an option to renew for an additional one (1) year period.
3. Triangle Steel and Supply Co., for Sections III and IV, terms 2% 15 days plus sales tax.
4. W.K. Montgomery Co., for Section V, terms 2% 30 days plus sales tax.
