

# RESOLUTION No. 214809

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the PACIFIC TELEPHONE AND TELEGRAPH COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of September 15, 1975, conveying to said City the permanent easement and right-of-way for a public street and incidents thereto, over, under, upon, along and across a portion of Lots 17 and 18, Block 5, Re-Subdivision of Crittenden's Addition, according to Map thereof No. 889 filed in the Office of the County Recorder of San Diego County, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named UNIVERSITY AVENUE.

That the City Clerk is hereby authorized and empowered to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the Office of the County Recorder of San Diego County.
