

RESOLUTION No. 214810Adopted on DEC 10 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of SUBURBAN DEVELOPERS, a co-partnership, executed in favor of The City of San Diego, bearing date of August 5, 1975, conveying to said City a portion of Pueblo Lot 1228 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, a copy of said Map having been filed in the office of the County Recorder of San Diego County, November 14, 1921 and is known as Miscellaneous Map No. 36, as more particularly described in said deed, be and the same is hereby approved.

That the expenditure of not to exceed \$825 from San Diego Park District No. 12F, Fund 3713 for acquisition of the above described property is hereby approved.

That the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
