

RESOLUTION No. 214812


Adopted on DEC 10 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of WARING VENTURE, a joint venture, executed in favor of The City of San Diego, bearing date of September 3, 1975, conveying to said City the permanent easement and right-of-way for a public street and incidents thereto together with a right-of-way for a fire hydrant and a street light standard, together with the right of ingress and egress, over, under, along and across a portion of Lot 67 of Rancho Mission of San Diego, according to Partition Map thereof on file in the Office of the County Clerk of said County in Action No. 348 in the Superior Court of said County entitled "Juan M. Luco, et al vs. The Commercial Bank of San Diego, et al", being a portion of Section 16, Township 16 South, Range 2 West, S.B.B.M., as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named ADOBE FALLS ROAD.

That the City Clerk is hereby authorized and empowered to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the Office of the County Recorder of San Diego County.
