Adopted on DEC 10 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of SAVINO and BENINA CORRAL, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of May 22, 1975, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, a portion of Lots 14, 15 and 16 of Sunshine Gardens according to Map thereof No. 1804 filed in the Office of the San Diego County Recorder August 27, 1924, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named IMPERIAL AVENUE.

That the expenditure of not to exceed \$4,300 from Gas Tax Fund 220 for acquisition of the above described property is hereby authorized.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
