
Adopted on _____

That the acceptance by the City Manager of that deed of YONEKO ESAKI, and JUNE ESAKI YAMASHITA, a married woman as her sole and separate property, as joint tenants, executed in favor of The City of San Diego, bearing date of July 29, 1975, conveying to said City the permanent easement and right-of-way for an earth excavation or embankment, slope or slopes and incidents thereto, over, under, upon, along and across a portion of Pueblo Lot 297 of the Pueblo Lands of San Diego according to Map thereof made by James Pascoe in 1870, as more particularly described in said deed, be and the same is hereby approved.
