
Adopted on DEC 10 1975

That the acceptance by the City Manager of that deed of CHURCH OF CHRIST, an unincorporated religious association, executed in favor of The City of San Diego, bearing date of July 10, 1975, conveying to said City the permanent easement and right-of-way for an earth excavation or embankment, slope or slopes and incidents thereto, over, under, upon, along and across a portion of Lot 6 in Block 11 of Silver Terrace, according to Map Thereof No. 695, filed in the Office of the Recorder of said San Diego County, December 12, 1891, as more particularly described in said deed, be and the same is hereby approved.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
