

RESOLUTION No. 214823Adopted on DEC 10 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

BE IT FURTHER RESOLVED, that the expenditure of \$47,600 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above referenced services.
