BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 85.04 of the San Diego Municipal Code, the USE of the following described streets be and it is hereby PROHIBITED AT ALL TIMES TO COMMERCIAL VEHICLES OF THE RATED CAPACITY OF ONE TON OR MORE, NOT ORIGINATING OR TERMINATING ON SAID STREETS:

JUTLAND DRIVE, between Morena Boulevard and Luna Avenue; and


LUNA AVENUE, between Jutland Drive and Clairemont Mesa Boulevard.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and they are hereby authorized to be made on said streets.

BE IT FURTHER RESOLVED, that the regulations hereinabove imposed shall become effective upon the installation of such signs.
