Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, entitled "G-W INDUSTRIAL PARK UNIT NO. 4 Being a subdivision of a portion of the west half of the west half of the Southwest Quarter of the Northwest Quarter of Section 11, Township 15 South, Range 3 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to the official plat thereof, together with that portion of of Carroll Road (Road Survey No. 466) dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Carroll Road for public purposes, and said portion of street is hereby declared to be a portion of a public street and dedicated to the public use.
