


RESOLUTION No. 214849

That the expenditure of \$645,000 from 3021 Deposit Trust Fund is hereby authorized solely and exclusively for the purpose of providing funds for the City's contribution for improvements in San Diego Park District No. 11 (Navajo Canyon) as more particularly described in Resolution of Intention No. 214599 and pursuant to the San Diego Park District Procedural Ordinance of 1969 and the Municipal Improvement Act of 1913.
