WHEREAS, the Train consists of ten exhibit cars containing a range of exhibits including George Washington's copy of the Constitution, moon rocks, and a copy of the Louisiana Purchase; and

WHEREAS, The City of San Diego Bicentennial Committee unanimously approved the visit of the Freedom Train; and

WHEREAS, the City Council of The City of San Diego finds and declares that the appearance of the Freedom Train in this City would be an appropriate Bicentennial event and wishes to make said train available to the citizens of this City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an agreement with The American Freedom Train Foundation, Inc., providing for the appearance of the American Freedom Train in San Diego during the period of

BE IT FURTHER RESOLVED, that the low bid of Aztec Bus Lines be accepted and the City Manager be authorized to enter into a contract for the furnishing of bus rentals as may be required for the purpose of transporting citizens of San Diego to and from Miramar Naval Air Station during the period of January 14 through January 18, 1976, inclusive, per prices on file in the Purchasing Department.

BE IT FURTHER RESOLVED, that the expenditure of \$27,000 be and it is hereby authorized out of Transient Occupancy
Tax Fund 224 Contingency Reserve (52.99), solely and exclusively, for the above purposes.
