WHEREAS, The City of San Diego proposes to improve Camino Del Rio South from Texas Street to Interstate 805 under the combined provisions of the Improvement Acts of 1911 and 1913; and

WHEREAS, the City requires engineering services for construction of the above-mentioned improvements; and

WHEREAS, E. F. Cook and Associates, Ltd., is willing to provide such engineering services and has been selected in accordance with Council Policy 300-7 having been considered on the basis of its experience and expertise in the design engineering field and its ability to complete the work in the time allocated; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with E. F. Cook and Associates, Ltd., a California corporation, to provide professional engineering services for design of Camino Del Rio South improvements between Texas Street and Interstate 805, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 753665.
