

RESOLUTION NO. 214904 DEC 17 1975

WHEREAS, Section 21 of the San Diego Municipal Code specifies those days to be observed as holidays in The City of San Diego; and

WHEREAS, said section provides that if a holiday falls on a Sunday, the Monday following shall be considered as the legal holiday; and

WHEREAS, no provision was made in said section for holidays falling on Saturdays; and


WHEREAS, to rectify such situation, the Council adopted Council Policy No. 300-3 providing that when a specified holiday falls on a Saturday, the Council shall, upon recommendation, provide alternate days to replace those holidays falling on Saturday; and

WHEREAS, December 25, 1976 (Christmas Day) and January 1, 1977 (New Year's Day) fall on Saturday and it is now desired to substitute alternative days in lieu thereof; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That pursuant to the provisions of Council Policy No. 300-3, the Council hereby declares that Friday, November 26, 1976, and Friday, December 24, 1976, shall be legal holidays for The City of San Diego in lieu of Saturday, December 25, 1976, and Saturday, January 1, 1977, respectively.
