WHEREAS, MAY ENGINEERING, by Elliott M. May, appealed the decision of the Planning Director in denying the Preliminary Parcel Map of a two-parcel division of Lot 19 and a portion of Lot 18, Block G, Redland Gardens Extension; and

WHEREAS, on November 18, 1975, the motion by the Planning Commission to approve said Preliminary Parcel Map failed to receive four affirmative votes and was deemed denied; and

WHEREAS, on November 7, 1975, pursuant to the provisions of Section 101.0506 of the San Diego Municipal Code, MAY ENGINEERING, by Elliott M. May, appealed the decision of the Planning Commission; and

WHEREAS, said appeal was set for public hearing on December 18, 1975, and testimony having been heard, evidence having been submitted and the City Council having fully considered the matter and being fully advised concerning the same; and

WHEREAS, the City Council, in considering said appeal is empowered by the provisions of Municipal Code, Section 101.0506, to affirm, reverse or modify in whole or in part any determination of the Planning Commission, subject to the limitations as are placed upon the Planning Commission by the Municipal Code; NOW, THEREFORE,
