

RESOLUTION NO. 214925

WHEREAS, the City - County Task Force on Consolidation of Services and Facilities, by authorization of the City Council and the Board of Supervisors, has reviewed the past and anticipated future needs of local government agencies for data and opinions obtainable from field surveys and compared the advantages of various collective actions to obtain such data; and

WHEREAS, the Center for Survey Research (SDSU), the Urban Observatory of San Diego and the San Diego State University Foundation are uniquely qualified to collect data and conduct public opinion surveys needed by the City and County at a substantial savings to both; and

WHEREAS, the City - County Task Force on Consolidation of Services and Facilities has recommended that, when necessary, joint surveys be conducted by City and County under contract with the Center for Survey Research (SDSU) for professional survey advice with the Urban Observatory of San Diego as the administrative agency and the San Diego State University Foundation as the fiscal agency, with City and County each contributing \$7,500 to fund an initial omnibus survey; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby approves the concept and authorizes negotiation of an administrative agreement between City and

County and the Center for Survey Research (SDSU) for professional assistance in the design and execution of surveys for local government agencies; naming the Urban Observatory of San Diego as the coordinator and administrating agency and the San Diego State University Foundation as the fiscal agency for such surveys. Said Agreement shall be presented to the City Council for final approval.

BE IT FURTHER RESOLVED, that the City Council hereby waives Council Policy 300-7 relating to the selection of consultants because the survey activity will be a joint City-County venture, and because the cost for the proposed surveys performed by the above named organizations will be significantly lower than if consultants were obtained through open bidding.

BE IT FURTHER RESOLVED, that the amount of \$7,500 in the Unallocated Reserve be hereby encumbered for the purpose of funding an initial omnibus survey for information and opinions in the area of community development public services and budget priorities, pending final approval of the above-mentioned agreement by City and County.
