2. That the expenditure of \$606,000.00 is hereby authorized from Water Revenue Fund (Fund No. 502) of the City of San Diego solely and exclusively for the purpose of providing funds for MODIFICATIONS TO THE ALVARADO WATER FILTRATION PLANT in the City of San Diego, and related costs.
