1. That the bid of \$19,049.00 by SELECT ELECTRIC, INC., a corporation, for the CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTION OF INGRAHAM STREET AND LA PLAYA AVENUE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 753063.

That the expenditure of \$23,997 is hereby authorized out of the Gas Tax Fund (Fund No. 220), and the expenditure of \$8,730 is hereby authorized out of the Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTION OF INGRAHAM STREET AND LA PLAYA AVENUE in the City of San Diego, and related costs.
