

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Agreement with ENGINEERING ALLIANCE CORPORATION to increase the maximum compensation for consultant engineering services for the Encanto Trunk Sewer Project (Phase II), under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 753728.

BE IT FURTHER RESOLVED, that the expenditure of \$6,000 is hereby authorized out of the Unallocated Reserve, and the City Auditor and Comptroller be and he is hereby authorized to transfer said amount within the Sewer Revenue Fund 506 to the Engineering Sewer C.I.P., for the sole and exclusive purpose of providing funds for the above services.
