

RESOLUTION No. 214963Adopted on DEC 24 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$6,000 from Sewer Revenue Fund 506, \$19,000 from Water Revenue Fund 502 and \$99,028 from Capital Outlay Fund 245 of The City of San Diego is hereby authorized solely and exclusively for the purpose of providing funds for (1) the purchase of necessary items of communications equipment from priced equipment lists in the Regional Communications Equipment Specifications approved by this Council, and (2) performance of the necessary work by City Forces.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the improvement of radio communications systems of the Police, Transportation, General Services and Water Utilities Departments, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
