


**RESOLUTION No. 214969**Adopted on DEC 24 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of PENASQUITOS, INC., an Illinois corporation, executed in favor of The City of San Diego, bearing date of November 20, 1975, conveying to said City the permanent easement and right of way for public streets and incidents thereto, over, under, across and along those portions of those certain private streets lying within Parcel 1 of Parcel Map No. 1008 filed in the Office of the County Recorder of San Diego County more particularly shown as Caminito Calma, Caminito Raposa, Caminito Tranquilo and Caminito Lindo; and said streets are hereby declared to be public streets and dedicated to the public use and are hereby named Camino Calma, Camino Raposa, Camino Tranquilo and Camino Lindo.
