

RESOLUTION NO. 214971

WHEREAS, The City of San Diego has entered into an agreement with the United States of America, acting by and through the Secretary of Housing and Urban Development (HUD) to obtain financial assistance to build and operate for twenty (20) years a neighborhood facility which is commonly called the San Ysidro Community Center; and

WHEREAS, City has fulfilled part of its said obligation to HUD by utilizing the Economic Opportunity Commission of San Diego (EOC) to operate said facility from 1969 to October 31, 1975; and

WHEREAS, EOC is no longer able to act as the project operator for the City for the duration of the HUD agreement which extends to May 27, 1989; and

WHEREAS, the organization called Metropolitan Area Advisory Committee (MAAC) is ready, willing, and able to assume the operational responsibility for said facility from January 1, 1976 through May 27, 1989; and

WHEREAS, the City is required under said HUD agreement to obtain a community service operator for said facility until May 27, 1989; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the
